**Privacy Notice** 

This Privacy Notice refers to the processing of personal data performed by **Brink's Romania**, with headquarters in Sos. Pipera, Nr.42, 12<sup>th</sup> Floor, District 2, Bucharest, Romania, **as a personal data controller.** 

The document applies to the following data subjects:

- 1. Representatives / employees of our business partners (customers or suppliers);
- 2. Representatives of potential suppliers or potential customers;
- 3. Visitors of Brink's Romania premises;
- 4. Visitors of Brink's Romania website, Brink's Romania social media pages;
- 5. Individuals who send us requests, complaints, notifications, etc.
- 6. Trainings participants.

1. In the case of representatives / employees of customers / suppliers, it is possible to process the following personal data:

• name,

- •first name,
- function,
- name of employer,
- work e-mail address,
- office address,
- work phone,
- signature;

• user data, IP, location if they use IT applications of our company,

- for the following purposes:
- concluding / executing the contract with the clients / suppliers that the data subjects represent;

• maintaining and improving the contractual relationship (including, to answer any questions, requests, complaints);

• marketing addressed to the legal entities that the data subjects represent (such as, for example, communications and offers regarding our products, services and promotions, marketing analysis, feedback requests, etc.).

The legal basis of these processing is a contractual one or the legitimate interest of our company, as the case may be.

2. In the case of individuals representing potential customers or suppliers, it is possible to process the following personal data:

- name,
- •first name,
- position,
- name of employer,
- work e-mail address,
- office address,
- work phone,
- signature;
- for the following purposes:

marketing addressed to the legal entities that the data subjects represent (such as communications and offers regarding our products, services and promotions, marketing analyzes, feedback requests, etc.);
initiating collaboration and concluding commercial contracts.

The legal basis of these processing is the legitimate interest of our company or the consent of the data subjects, as the case may be.

3. It is possible to process the following personal data of the visitors of the Brink's Romania premises:

• data from the identity document, information regarding the purpose, date and duration of the visit;

• images (video recordings -CCTV).

The purpose of the processing is to ensure the security of persons and property in the premises of Brink's Romania.

The legal basis of the processing is, as the case may be, the legitimate interest of our company or the existence of legal obligations incumbent on Brink's Romania according to *Law 333/2003 (republished) on the protection of objectives, assets, values and protection of persons and Its implementing rules.* 

4. For the visitors of the Brink's Romania website and of the social media pages of Brink's Romania, the following applies:

When we use social media platforms, we assume responsibility for the content of published materials, but the responsibility for the use and administration of cookies belongs to those platforms.

In the case of Brink's Romania website, the use of cookies is based on the explicit consent expressed by visitors.

5. In the relationship with individuals who send us requests, complaints, notifications, etc. it is possible to process the following personal data provided by them:

- name,
- first name,
- email adress,
- postal adress,
- phone number,
- signature
- location at a certain date,

• data collected by applications used to ensure IT security.

The basis of these processing is the legitimate interest of our company or the implicit consent of the data subjects, as the case may be.

6. In the case of individuals who participate on their own to trainings organized by Brink's Romania, the personal data processed may be:

- the data from the identity document,
- email adress,
- postal adress,
- phone number,
- signature
- employer's name.

The basis of these processing is the conclusion / execution of the contract with the persons concerned.

Personal data are stored in accordance with our personal data storage policy, by which a storage period is assigned depending on the purpose of processing and the category of data processed. The respective periods are based on the legal provisions (especially in the field of personal data protection), also taking into account the obligations to store certain data, the applicable limitation periods, the recommended best practices and the purposes of our activity.

Currently, we do not transfer and do not intend to transfer the data of data subjects to other companies, organizations or persons from third countries or to international organizations.

We limit access to personal data to what is strictly necessary, but in certain situations it is possible to disclose the personal data to processors, institutions, authorities, for example:

· for legitimate reasons related to our activity,

• for ascertaining, defending and exercising ours or another person's rights or interests

• because we have a legal obligation to disclose data to public authorities or other natural or legal persons.

## Your rights as a data subject

As a data subject, you have the following rights:

• of access - you can obtain information about the processing of your personal data, as well as a copy of those;

• to rectification - you can request the completion or updating of your personal data in case they are incomplete or inaccurate;

• to be forgotten - in certain situations, you may request the deletion of your personal data;

• to restrict processing - in certain situations, you can request the conditioned processing of the personal data until the settlement of certain operations related to your data;

• to object- in the case of processing based on legitimate interests, you can motivated object to such processing;

• data portability - you can request the transmission of personal data provided by you and processed by automatic means in a structured format, which can be read automatically.

If the legal basis for the processing of these data is your consent, you have the right to refuse the processing of the data, but in this situation we will not be able to include you in the processes for which the processing was necessary.

You also have the right to withdraw your consent at any time, without affecting the legality of processing up to that time or processing performed on other legal grounds.

Each of the above rights can be exercised by sending a written request, signed and dated, to:
